- C) Letter from DIMIA supporting refugee status
Confidential statements of support from doctor verifying health condition of family member
Confidential statements of support from responsible person verifying carer responsibilities e.g doctor, social worker, counsellor, religious or community leader.
- D) Proof of Austudy, Health Care Card, tax return, letter from employer outlining hours and pay, proof of parents receiving Family Tax benefit.
- E) Letter from Disability Liaison Unit and proof of registration with the DLU:
 - Each piece of supporting documentation must be a certified copy
 - Please do not send originals as they will not be returned
 - Documents must be legible and easy to read
- F) Statement of hardship such as recent loss of primary income or fee support or major personal incident with significant loss of funds such as major car damage or hospital bills (provide a statement of no more than 500 words with supporting financial documentation)
- G) Statement of results (can be downloaded from WES) indicating at least a 60% average across all law studies
